- \_\_\_\_\_ **ASPHALT/CEMENT CONTRACTOR** - \$5,000 Surety Bond only if working in parkway
- \_\_\_\_\_ **ELECTRICAL CONTRACTOR** – Copy of current Electrical License required
- \_\_\_\_\_ **HVAC CONTRACTOR** – Copy of registration from other city, town or Village of LaGrange
- \_\_\_\_\_ **MASONRY CONTRACTOR** - \$5,000 Surety Bond Required
- \_\_\_\_\_ **EXCAVATING** - \$5,000 Surety Bond Required
- \_\_\_\_\_ **PLUMBING CONTRACTOR** – If the contractor has a current State of Illinois License and is not doing work in the parkway/street, a \$10,000 Surety Bond is necessary. If the contractor does not have a current State of Illinois license, then a City of Chicago registration must be provided together with a \$10,000 Surety Bond whether or not work is being done in the parkway/street.
- \_\_\_\_\_ **SPRINKLER CONTRACTOR** - Contractors must provide a \$10,000 Surety Bond, a copy of the CCCDI License and be certified as a plumbing contractor and meet the same Village registration requirements as a plumbing contractor or they may register as a general contractor and have their hired plumber register separately.
- \_\_\_\_\_ **ROOFING CONTRACTOR** – Copy of current State of Illinois License required
- \_\_\_\_\_ **SEWER CONTRACTOR** - \$10,000 Surety Bond - Copy of current State of Illinois License or City of Chicago Registration required.
