

**APPLICATION FOR LICENSE FOR
RETAIL SALE OF LIQUOR
UNDER THE
VILLAGE OF LA GRANGE
ALCOHOLIC LIQUOR CONTROL ORDINANCE**

CORPORATION

The undersigned hereby makes application for the issuance of a license to engage in the business of selling alcoholic liquors, as indicated hereafter, for the period commencing

_____, (date) and ending April 30, 20__ . (Please check the Class for which application is made. Class License Fees payable in advance on or before May 1 of each year.) A **non-refundable** application fee of \$500 is due with this application.

- CLASS A — \$500 — A Class A retail dealer's license shall authorize the licensee to engage in business as a retail dealer in beer and wine not for consumption on the premises where sold, provided such business is merely incidental to other businesses conducted by him on the same premises.
- CLASS B — \$500 — A Class B retail dealer's license shall authorize the licensee to sell beer and wine at retail for consumption on the premises where sold; provided that such license shall be issued only to a person engaged in conducting or operating an establishment, the principal business of which is serving foods or ice cream or non-alcoholic beverages or where the sale of beer and wine is not the principal business of such establishment.
- CLASS C — A Class C license shall authorize the licensee to sell alcoholic liquor by the drink at retail for consumption on the licensed premises on which food also is sold for consumption. In order to qualify for a license in this class and in order to remain qualified for any subsequent renewal of such license, the person applying, or the licensee, must prove to the satisfaction of the Village that more than 60% of the gross annual revenue of such person's business on the licensed premises has resulted from the sale of food. The licensee shall be required to maintain such requirement at all times, and his business records may be subjected to audit from time to time for verification of the maintenance of such major percentage of gross annual income from food. There shall be two types of Class C license, as follows:

- CLASS C-1 — \$2,000 — A C-1 license shall authorize the licensee to have a bar or lounge area primarily engaged in the sale of alcoholic beverages to the public on any one floor. Alcoholic liquor may be served at either the bar and lounge area or in the general seating area.
- CLASS C-2 — \$1,250 — A C-2 license shall authorize the serving of alcoholic liquor in the establishment in the fashion commonly referred to as a service bar; that is, as a complement to the serving of food; and this license shall not authorize any bar or lounge area.
- CLASS D — \$1,500 — The Class D license shall authorize the licensee to sell alcoholic liquor at retail in packages or containers not for consumption on the licensed premises, provided:
 1. That more than 50% of the licensee's gross annual revenue has resulted from retail sales of goods other than liquor;
 2. That no more than 40% of the total floor area of the licensee's premises is devoted to the sale of alcoholic liquor
- CLASS E — \$500 — A Class E license shall authorize a club, as defined herein, to sell alcoholic liquor by the drink for consumption on the licensed premises.
- CLASS F — \$1,250 — A Class F license shall authorize alcoholic beverages served as an adjunct to a movie theater seating at least 300 patrons which may be accommodated on multiple screens. Such license shall authorize the sale of alcoholic liquor by the drink at retail for consumption on the licensed premises on which food also is sold for consumption. In order to qualify for a license in Class F, the licensee must prove to the satisfaction of the Village that more than 70% of the gross annual revenue of such person's business on the licensed premises has resulted from the sale of food and theater ticket admission. The licensee shall be required to maintain such requirement at all times and his business records may be subjected to audit from time-to-time for verification of the maintenance of such major percentage of gross annual income for food. No package sales shall be allowed. This classification shall only authorize a service bar with wait staff service.
- CLASS G — \$500 — A Class G license shall authorize the licensee to serve alcoholic beverages as part of a catering business which maintains a business facility within the Village and for which a business license has been issued. A "caterer" is any properly licensed individual who performs as a business, the service of providing food, or food and alcoholic beverages, to any location within or outside of the Village, and which is to be consumed on the premises within 36 hours of delivery. Before each Class G license is approved, the applicant must present evidence satisfactory to the Liquor Commissioner, of the following:

- (a) That the applicant is, or will be engaging in a bonafide catering business licensed to do business in the Village;
- (b) That more than 60% of the licensee's gross annual revenue has, or will be, from the sale of catered food;
- (c) That licensee operates, or will operate, its offices and/or distribution point in accordance with all Village zoning and health regulations;
- (d) That licensee comply with all other codes and ordinances of the State of Illinois, and of the Village, applicable to the catering business.

Any caterer holding a valid Class G license shall be allowed to provide a catering service which includes the serving of alcoholic beverages in any zoning district within the Village, and shall not be obligated to obtain a "temporary license" as required under Section 111.17, or any other liquor license described herein.

HOURS FOR SALE OF ALCOHOLIC LIQUOR

The hours of operation under a Class B, C and E license shall be from 11:00 a.m. to 1:00 a.m. on the following day, except for Fridays and Saturdays, when the hours shall be from 11:00 a.m. to 2:00 a.m. and for Sundays, when the hours shall be from 12:00 p.m. to 1:00 a.m. on Monday.

The hours of operation under a Class A and D license shall be from 8:00 a.m. to 11:00 p.m. except Sundays when the hours shall be 12:00 p.m. until 11:00 p.m.

The hours of operation under a Class F license shall be from 12 p.m. to midnight, except for Fridays and Saturdays when the hours shall be from 12 p.m. to 1:00 a.m. on the following day.

The Liquor Commissioner shall have the power to grant extended hours for the sale of alcoholic liquor for holidays and special events. Written requests for extended hours for holidays and special events shall be submitted to the Liquor Commissioner not less than 5 days prior to the requested date.
