Re: Monthly Report for December 2020

Attached for your review are the general statistics for the shift activities for the month of December 2020. Work continued on hiring new officers, budget preparation for the fiscal year 2021 – 2022, my transition to interim Chief of Police, and day-to-day activities as we moved into the busy holiday season.

On Monday, December 7th, Officer Casey Gomorzak completed Step 1 of the Field Training Program with Officer Ryan Nemecek and on Tuesday, December 8th, he began Step 2 working with Officer Taylor Falls.

On Wednesday, December 9th, the La Grange Board of Fire and Police Commissioners conducted four oral interviews for the position of Police Officer. The candidates that were interviewed were part of the most recent Police Eligibility Register that was approved on November 18th. All four candidates passed the oral interview and began the background investigation phase of the process. The Police Department currently has three (3) Police Officer vacancies.

On Wednesday, December 16th, the Police Department received confirmation from the Illinois Association of Chiefs of Police (ILACP) that its Use of Force policies met the new federal standards for certification. The process was facilitated by the Illinois Chief of Police Association, on behalf of the United States Attorney General, and required a review of several “Use of Force” policies to ensure that the La Grange Police Department was in compliance with these new mandates. I have attached a link to the ILACP website where the process is explained [ILACP Use of Force Certification](#). A copy of the certification letter can be found on the Village’s website at [Certification Letter](#). Although the certification is required to gain eligibility for federal discretionary grants, the La Grange Police Department’s Use of Force policies meet the requirements of the Executive Order on Safe Policing for Safe Communities.

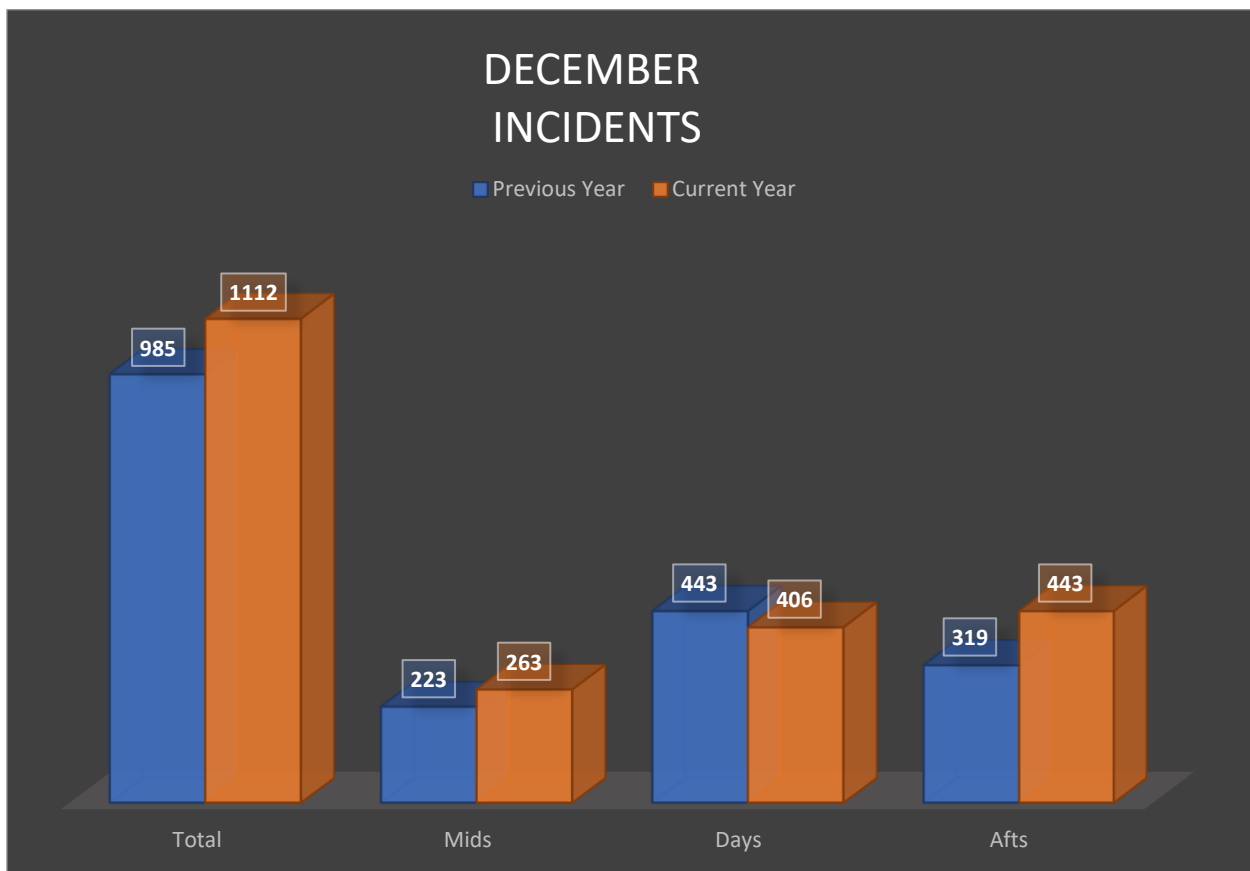
On Wednesday, December 16th, the La Grange Board of Fire and Police Commissioners conducted five more oral interviews for the position of Police Officer. Due to the rigorous hiring process, it is not uncommon to have to conduct multiple interviews/background investigations in order to find a viable candidate.

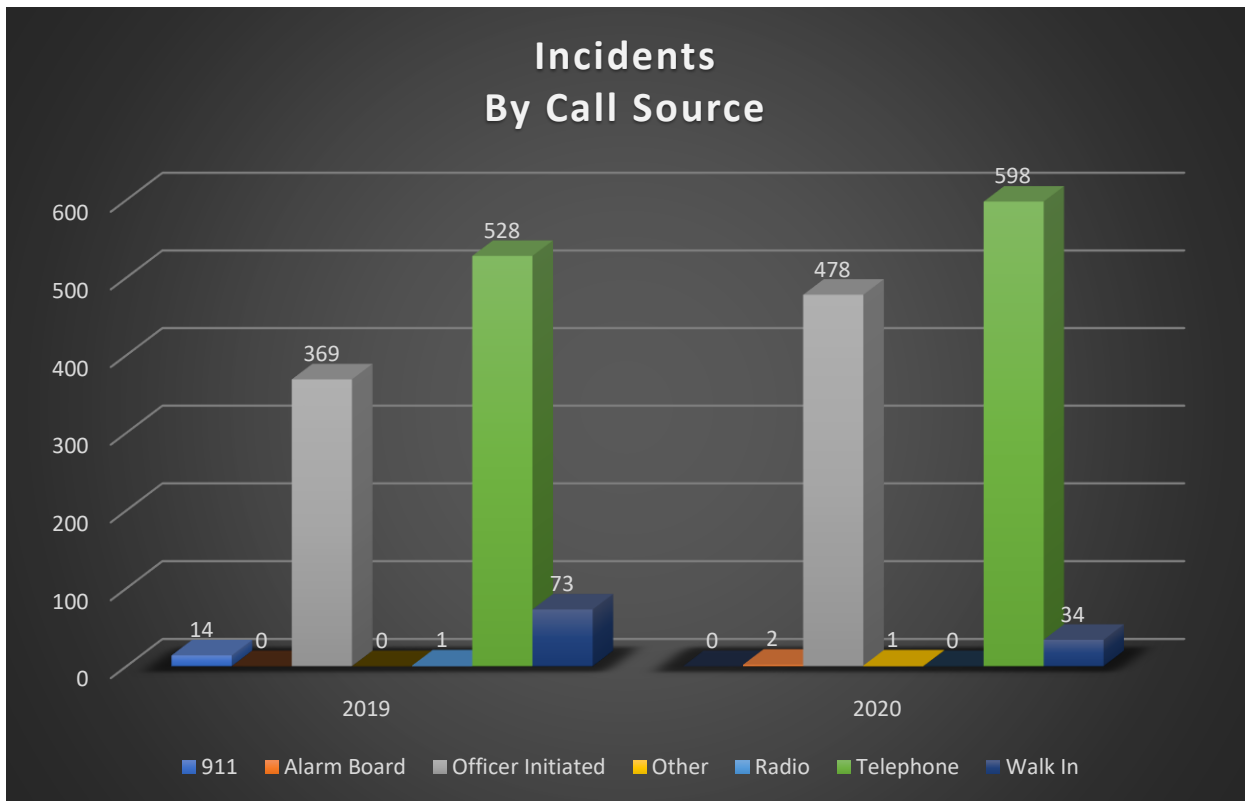
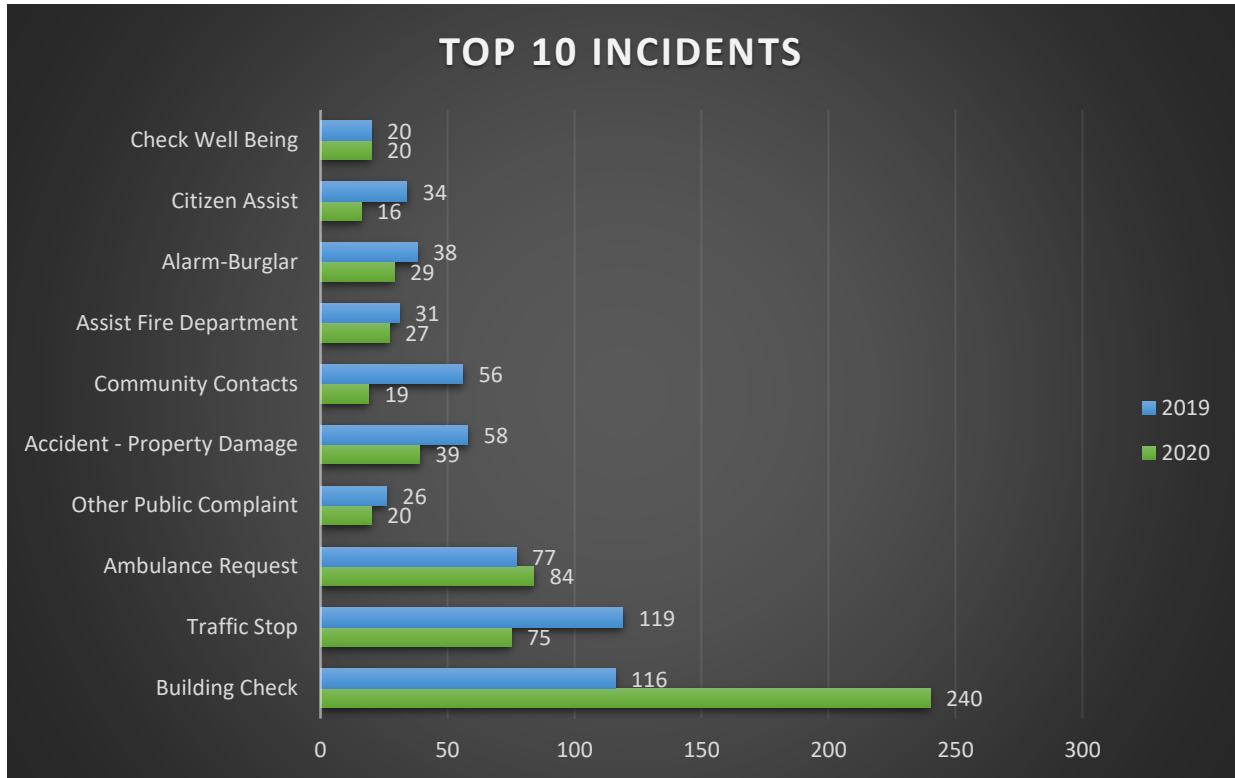


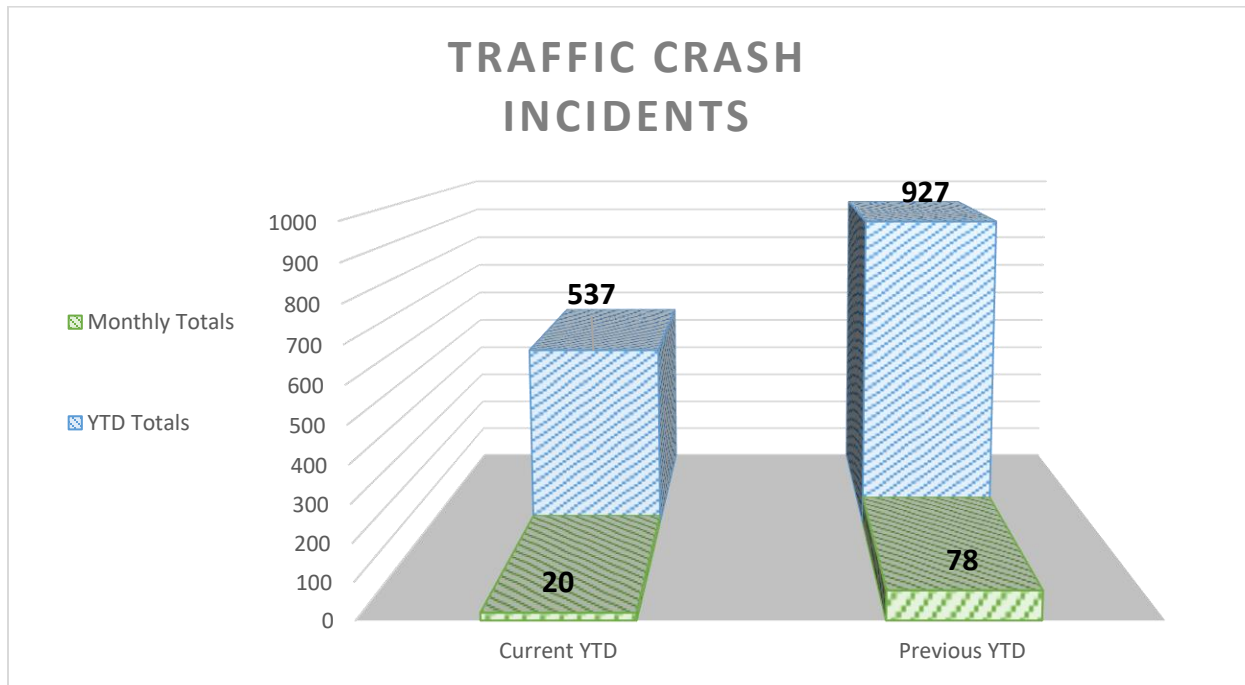
During the latter part of December, the Police Department participated in a toy drive in which toys were donated for the All Our Children’s Advocacy Center (AOCAC). The purpose of the toy drive is to provide Christmas presents to children who might not otherwise receive such gifts. In addition,



\$1,632 was raised as part of a “pie-throwing” contest. The top two money raisers got to throw a pie in the face of the Chief and Deputy Chief. The money was used by the AOCAC to purchase gift cards for older children.







December Training

On Tuesday, December 8th, Deputy Chief Dave Rohlicek participated in a one-day virtual class titled, “Management of Field Training Programs.” The class is designed to provide students with the skills needed to effectively manage the field training process at their agencies, regardless of the model used. The course covered topics such as why proper supervision and management of the field training process is important, the agency's responsibility to supervise the process, management issues common to all field training programs, including selection, evaluation, retention, training, training failures, scheduling, and burnout and management issues unique to Evaluative Programs. The class was sponsored by NEMRT.

Due to the surge in COVID-19 cases, all in-person training was canceled for the month of December. This eliminated virtually all of the training that had been scheduled.

DAYSHIFT ACTIVITIES

ARRESTS:

Philip A Bush, 39YOA, of LaGrange, IL was charged with battery following an incident at 31 E Ogden Ave.

OTHER POLICE ACTIVITY:

The Dayshift shift completed 42 traffic contacts during December of 2020. Shift Officers completed 28 Illinois Traffic Crash reports. The shift Officers issued 191 parking/compliance citations for equipment and other parking violations. The shift Officers conducted 35 Building/Business Premise Checks and Foot Patrols.

TRAINING:

Officer Nemecek began the 1st Step of the FTO process with Officer Gomorzak Lexipol DTB's and Illinois Police Law completed.

AFTERNOON SHIFT ACTIVITIES

INVESTIGATIONS:

Afternoon Shift members conducted several Investigations into Identity Thefts involving the Illinois Department of Employment Security. No suspects have been identified at this time. The cases were closed.

S/L McDermott, Ofc. Falls, Ofc. Comstock, Ofc. Gomorzak and Inv. Kang responded to a robbery that just occurred at the BMO Harris Bank. After ensuring the scene was secure and all parties were safe officers canvassed the area for cameras, evidence, and the offender(s). Inv. Kang processed the scene, collected surveillance video, and tendered all findings over to the Federal Bureau of Investigations (FBI). Case pending.

ARREST / CITATIONS:

S/L. McDermott, assisted by Ofc. Comstock, Ofc. Falls and Inv. Kang, located and arrested a 15-year-old juvenile wanted for a Robbery that occurred in October 2019. The juvenile was charged and released to their parent with a referral to Cook County Juvenile Court.

Ofc. Falls and Ofc. Nemecek, assisted by Ofc. Irizarry and Sgt. Coleman, while investigating separate battery complaints identified the same offender involved in two cases. Ofc. Nemecek later located and arrested the offender, a 39-year-old male from LaGrange, IL. The offender was charged with two counts of Battery and was released after posting a bond with a return court date.

OTHER POLICE ACTIVITY:

Afternoon Shift Officers responded to 443 calls for service, completed 74 building checks, 22 special watches, 58 initial case reports, 20 supplement reports, and 2 arrest reports.

TRAINING:

Ofc. Gomorzak entered into phase two of the field training program under the guidance of Field Training Officer Falls.

MIDNIGHT SHIFT ACTIVITIES

ARRESTS:

Ofc. Wolf, Ofc. Kaiser and Ofc. Niewold arrested a 17-year-old juvenile female subject from Bellwood and a 16-year-old juvenile male subject from Chicago for Criminal Trespass to Vehicle and Resisting/Obstructing a Peace Officer. Ofc. Wolf attempted to conduct a traffic stop on a vehicle that was reported stolen out of North Riverside. Once the suspect vehicle stopped, the driver and two passengers fled the vehicle/scene on foot. After a short foot pursuit, the above officers, with assistance from Countryside P.D. officers, were able to apprehend the female and male juvenile subjects who were passengers in the vehicle. The suspect male driver successfully fled the scene on foot. The two juvenile subjects were processed and then released to their parents/guardians. The Investigations/Juvenile Division is conducting a follow-up investigation to identify and locate the suspect male driver.

Officer Gomorzak and FTO Herrera arrested a 25-year-old male subject from LaGrange, who had (3) active Warrants out of LaGrange for Criminal Trespass to Property. The subject was processed and transported to the Cook County Bridgeview Courthouse for a bond hearing.

OTHER POLICE ACTIVITY:

The Midnight shift completed 7 traffic contacts and investigated 5 property damage traffic accidents, one of which was a hit and run accident. Shift Officers issued 50 parking citations for overnight parking and other violations. Shift Officers conducted 154 Building/Business/Special Watch Premise Checks and Foot Patrols. In addition, Probationary Officer Gomorzak joined the Midnight Watch to continue with Step 2 of his Field Training program with FTO Herrera and FTO Kaiser.

TRAINING:

The shift continued completing the monthly Police Law Institute online training lessons, along with the monthly Lexipol Daily Training Bulletins. In addition, several other scheduled training classes were unfortunately canceled due to increased statewide restrictions due to the COVID-19 pandemic.

INVESTIGATIONS DIVISION ACTIVITIES

INVESTIGATIONS:

Inv. Kang assisted the Day Shift with a Criminal Sexual Assault Investigation against a minor. The case is pending further investigation and analysis of evidence submitted to the ISP Laboratory.

Inv. Fulla conducted a follow-up investigation into a Domestic Battery complaint against a minor victim. Inv. Fulla appeared before the Grand Jury who returned a true bill indictment against the offender. The case is being prosecuted by the Cook County State's Attorney Office.

Inv. Kang assisted the Afternoon Shift with a Robbery that occurred at the BMO Harris Bank. Inv. Kang processed the scene, collected surveillance video, and tendered all findings over to the Federal Bureau of Investigations (FBI). Case pending.

ARREST / CITATIONS:

Inv. Kang processed and charged two 15-year-old juveniles wanted for a Robbery that occurred in October 2019. After being processed and charged the juveniles were released to the custody of their parents with a referral to Cook County Juvenile Court. The victims were notified of the arrests. Case closed.

OTHER POLICE ACTIVITY:

Inv. Kang and Inv. Fulla worked on numerous police applicant backgrounds in the process of the department/village hiring 3 candidates.

Inv. Fulla completed a 3-day online training related to Protective Intelligence Investigations.

Inv. Kang completed several backgrounds for Village Liquor License Applicants.
